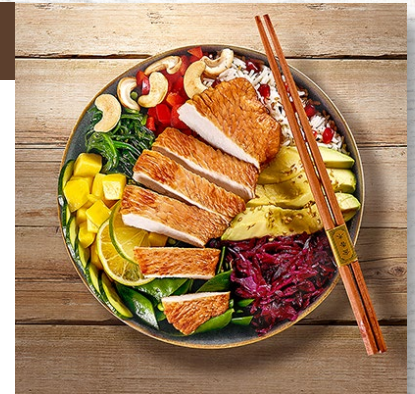


Turkey Schnitzel, unseasoned

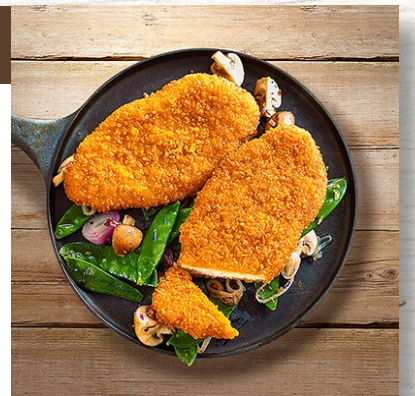

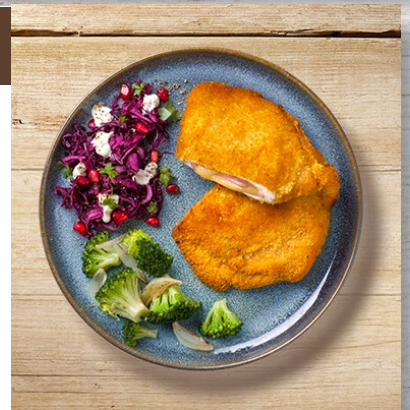
